EQUALIZED BILLING

No more surprises in your electric bill...



Here's how it works: Equalized Billing brings your highest bills down and your lowest bills up to nearly the same amount each month by averaging your bills over the past 12 months.

There's no charge for this service. You pay exactly what you ordinarily would for electricity, but the total will be spread out over a 12-month period, and you'll pay the same, or approximately the same, "equalized" amount each month.

By smoothing out the hills and valleys on your Brunswick EMC power bills, you won't have to deal with higher bills during the air conditioning season, the heating season, or during holidays or vacations, when your other expenses are generally a lot higher.

When you sign up for Equalized Billing, we'll compute your bill just like always. Your meter will still be read on the same schedule as in the past. The same billing card will arrive in the mail to tell you how much electricity you've used. But you'll only have to pay the equalized amount, which will be plainly shown on your bill.

The benefits of the Equalized Billing are many, but helping you plan and stay within a budget by eliminating those unpleasant surprises is perhaps the greatest benefit of all.

Equalized Billing Request and Agreement

I, _____, hereby request that I be placed on Brunswick Electric Membership Corporation's equalized billing plan. I understand that to qualify for equalized billing, I must own my residence and, if my residence is a mobile home, I must own my mobile home and lot. I have been a member of Brunswick EMC at least 12 months with a good payment record.

- A. To arrive at my monthly equalized amount, the prior twelve month's bills will be divided by twelve plus 10% and priced at the current rates.
I understand that my monthly equalized amount may be adjusted when:
 1. Rate changes are approved.
 2. History reflects original equalized amount is either too high or low.
- B. I agree to pay the monthly amount. Failure to do so shall result in being removed from the equalized list, with the total account balance due.
- C. I understand that should I add other Brunswick EMC services, the monthly charge will be in addition to my equalized payment.
- D. I agree to pay the equalized amount for twelve months with a settlement calculation in the anniversary month. If I have over paid, Brunswick EMC will credit this amount to my next bill; otherwise I will pay the settlement amount required. The amount for the next twelve months will be adjusted accordingly.
